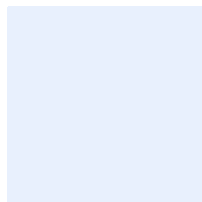
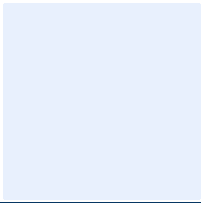


### 2. Conditions of use.
