

The domain www.robusta.es uses automatic collection procedures (Cookies) to gather personal information such as the type of browser or operating system, referring page, path, ISP (Internet Service Provider) domain, etc. all with the aim of improving the services provided. Cookies help us to tailor this website to your personal needs.

A cookie is a small file that is stored on the user's computer and allows us to recognise the user. The set of cookies helps us to improve the quality of our website, allowing us to customize to some extent the browsing experience of each user in our website. Cookies are currently essential for the functioning of the Internet, providing countless advantages in the provision of interactive services, facilitating your browsing and usability of our website.

Please note that cookies cannot harm your computer and that, in return, having cookies enabled helps us to identify and resolve errors and improve the browsability of our site.

Cookie policy:

Below we inform you about cookie types and their use:

- From the point of view of the **cookie lifetime** (the time that the cookie remains active in your device) you can divide cookies into two types.
 1. **Session cookies:** temporary cookies that remain in your browser's cookie file until you leave the website, so that it is not recorded on the user's hard drive. The information obtained via these cookies is used to analyse web traffic patterns. Ultimately, this allows us to provide a better experience by improving the content and making it easier to use.
 2. **Persistent Cookies:** are stored on your hard drive and our website reads them every time you revisit it. Persistent cookies have a specific expiry date. The cookie will stop working after that date. We generally use them to enable the user experience by remembering their browsing habits or, where appropriate, to facilitate purchase and/or registration services.
- From the point of view of **the purpose of each cookie**, there are also different types:
 1. **Technical Cookies:** are those that allow the user to browse through a website, platform or application and to use of the different options or services that exist in it, including those that the editor uses to allow the management and operation of the website and enable its functions and services.

Technical cookies, provided that they correspond to one of the following profiles, shall be exempt from compliance with the obligations set out in Article 22.2 of the LSSI* (i.e., obtaining consent for their installation and use by means of a notice banner, cookie policy):

- ✓ User-input cookies
- ✓ Authentication or user identification cookies (session cookies only) User security cookies
- ✓ User centric security cookies
- ✓ Multimedia player session cookies
- ✓ Load balancing session cookies
- ✓ Personalisation cookies for the User Interface
- ✓ Social plug-in content sharing cookies

** according to the EU Expert Working Group, in Article 29 of its Opinion 4/2012*

2. **Preference or personalisation cookies:** these are cookies that allow the website to remember information so that the user can access the service with certain characteristics that can differentiate their experience from that of other users, such as, for example, the language, the number of results to be shown when the user performs a search, the appearance or content of the service depending on the type of browser through which the user accesses the service, the region from which the user accesses the service, etc. If it is the user who chooses these characteristics (for example, selecting the language of a website by clicking on the icon of the flag of the respective country), the cookies will be exempt from the obligations of article 22.2 of the LSSI because it is considered a service expressly requested by the user, and this is provided that the cookies are used exclusively For the selected purpose.

3. **Analytical cookies:** are those that allow the party responsible for them to monitor and analyse the behaviour of the users of the websites to which they are linked, including the quantification of the impact of advertisements. The information collected through this type of cookies is used to measure the activity of the website, application or platform for the purpose of introducing improvements based on the analysis of visitor usage data.
4. **Behavioural advertising cookies:** these cookies store information on the behaviour of users obtained through the continuous observation of their browsing habits, which allows to display advertising based on their specific profile.

➤ Finally, from the point of view **of the entity that manages the cookies**, we can differentiate between:

1. **First-party cookies:** which are sent to the users' terminal from a computer or domain managed by the website publisher from which the service requested by the user is provided.
2. **Third-party cookies:** they are sent to the users' terminal from a machine or domain that is not managed by the editor, but by another entity that processes data collected through cookies.

CALZADOS ROBUSTA, S.L. stores all the information collected through cookies in a non-personalised format (IP address). This type of information obtained through cookies will not be disclosed outside CALZADOS ROBUSTA, S.L. except in those cases indicated in the section 'List and description of cookies', nor used for unsolicited communications.

Adequate privacy - Cookie management:

The user can configure cookie permissions at any time on our website by accessing the cookies configuration panel.

If the user so wishes, the registration of cookies may be subject to their acceptance during the installation or updating of the browser used. The user may at any time revoke their acceptance by means of the content and privacy configuration options available in each browser. However, if the user does not allow the installation of cookies in their browser they may not be able to access some sections of our website.
